

# **POLICY STATEMENT ON PROVIDER ACCESS**

#### INTRODUCTION

This policy statement sets out the school's arrangements for managing the access of providers to students at the school for the purposes of giving them information about the provider's education or training offer. This complies with the school's legal obligations under Section 42B of the Education Act 1997 and in line with the Skills and Post 16 Education Act

### STUDENT ENTITLEMENT

Students in years 7-11 are entitled:

- To find out about technical education qualifications and apprenticeships opportunities, as part of a careers programme which provides information on the full range of education and training options available at each transition point.
- To hear from a range of local providers about the opportunities they offer, including technical education and apprenticeships – through options evenings, assemblies, group discussions and taster events for a reasonable amount of time during the school day.
- To understand how to make applications for the full range of academic and technical courses.
- Students to have at least 2 occasions within each stage of their education with providers
- We will ensure that each registered student meets with a representative range of education and training providers to whom access is given and that the providers are providing the following set of prescribed information:
  - 1. information about the provider and the approved technical education qualifications or apprenticeships that the provider offers;
  - 2. information about the careers to which those technical education qualifications or apprenticeships might lead;
  - 3. a description of what learning or training with the provider is like; and
  - 4. responses to questions from the pupils about the provider or technical education qualifications and apprenticeships.
